As a contestant, you will be assigned a Holy Smoke Monk who will be your personal representative for the weekend. Contestants that sell BBQ to the public will receive a \$100.00 discount on their entry fee (fee refunded following event). Contestants that will be selling to the public must provide a food vendor license with this entry application. See Contestant Rules for more information.

**Free tour of The Winery at Holy Cross Abbey (plus free tasting session?)**

BBQ contestants who arrive Thursday afternoon will be treated to a free tour of the production facilities of The Winery at Holy Cross Abbey, plus a wine tasting session. Begins at 5:30 p.m. on Thursday, June 10. Holy Smoke!

**Monastery Mystery Cooking Contest (\$50.00 1st Place prize)**

The Monastery Mystery contest is open only to BBQ contestants (\$20 per entry; one entry per team). The Holy Smoke Showdown will provide all Monastery Mystery contestants with the same three mystery ingredients. Contestants then will prepare a dish "entirely on site" using all portions of the three mystery ingredients. Additional ingredients may be added. KCBS rules "will not" apply to presentation. Monastery Mystery dishes must be submitted for judging at 7 pm, Friday, June 11. See Contestant Rules for more information.

**Smokin' Salsa Contest (\$50.00 1st Place prize)**

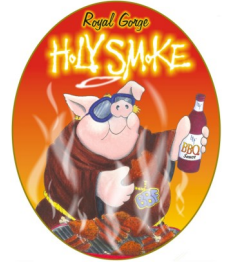
